These young adults will then play a key role in training the Young Adult Leaders at Casa Iskali (formerly Cabrini Retreat Center) in Des Plaines, IL from Friday evening, July 21 through Sunday evening, July 23 as well as throughout the Congress, July 24-27. During the Congress, Young Adult Coordinators will:

- Select and train Young Adult Leaders for morning and evening prayer
- Lead nightly small group discussions and prayer
- Set up and participate in all sessions
- Organize social and free time recreation
- Help Young Adult Leaders in enforcing rules
- Assist Young Adult Leaders in coordinating a variety show
- Encourage and support Young Adult Leaders
- Conduct debriefing meetings every evening during the Congress
- Perform other duties, as needed
